**ORDINANCE 6-2005**

**AN ORDINANCE ESTABLISHING FEES FOR BURIALS IN THE FLAG SPRING CEMETERY IN THE VILLAGE OF NEWTOWN, DISPENSING WITH THE SECOND AND THIRD READINGS, AND DECLARING AN EMERGENCY**

**WHEREAS**, the Council of the Village of Newtown, wishes to establish new fees for burials in the Flag Spring Cemetery , a municipal cemetery owned by the Village of Newtown under court order;

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Newtown, State of Ohio:

**SECTION 1.** Fees for grave openings and burials in the Flag Spring Cemetery located in the Village of Newtown are hereby established as follows:

Monday through Friday 8:00 a.m. to 2:00 p.m.  
Vault and Casket burial - \$450.00  
Cremains burial - \$100.00

Monday through Friday 2:00 p.m. to 4:00 p.m.  
Vault and Casket burial - \$550.00  
Cremains burial - \$100.00

Saturday 8:00 a.m. to 11:00 a.m.  
Vault and Casket burial - \$550.00  
Cremains burial - \$150.00

Saturday 11:00 a.m. to 2:00 p.m.  
Vault and Casket burial - \$650.00  
Cremains burial - \$150.00

**SECTION 2.** Infant burials, (baby vault and casket) shall be one-half of the above charges.

**SECTION 3.** There shall be no burials on Sundays or holidays or weekends that contain a holiday or have a holiday the Friday prior to or Monday subsequent.

**SECTION 4.** The counsel of the Village of Newtown, by at least three-fourths vote of all of its members, dispenses with the requirement that this ordinance be read on three separate days and authorizes its passage upon one reading.

**SECTION 5.**

This ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace, health, welfare and safety of the Village of Newtown. The reason for the emergency is to provide for the immediate change in charges for burials in the Flag Spring Cemetery.
