**ORDINANCE 18 -2005**

**AN ORDINANCE ESTABLISHING AND IMPOSING AN ADDITIONAL MUNICIPAL  
MOTOR VEHICLE LICENSE TAX UNDER OHIO REVISED CODE SECTION  
4504.172 AND DISPENSING WITH THE SECOND AND THIRD READINGS**

**WHEREAS**, the Council of the Village of Newtown, wishes to establish an additional municipal license tax on motor vehicles in the Village pursuant to Ohio Revised Code, Section 4504.172;

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Newtown, State of Ohio:

**SECTION 1.** For the purpose of paying the costs and expenses of enforcing and administering the tax provided for in Ohio Revised Code Section 4504.172, for the purpose of supplementing the revenue already available to municipal corporations under Ohio Revised Code Sections 4504.04, 4504.06, 4504.17, or 4507.171, and to provide additional revenue for the purposes set forth in those Ohio Revised Code sections, the Council of the Village of Newtown hereby levees an annual license tax in the amount of \$5.00 per motor vehicle registered in the Village of Newtown.

**SECTION 2.** The license tax established under Section 1 of this ordinance is hereby levied on all motor vehicles, the district of registration of which, as defined in Section 4503.10 of the Ohio Revised Code, is in the Village of Newtown.

**SECTION 3.** This additional motor vehicle license tax is in addition to any other motor vehicle license tax currently being levied in the Village of Newtown.


**SECTION 4.** The additional municipal motor vehicle license tax established under this ordinance shall commence at the earliest possible time and shall continue in effect until repealed.

**SECTION 5.** The Council of the Village of Newtown, by at least three-fourths vote of all of its members, dispenses with the requirement that this ordinance be read on three separate days and authorizes its passage upon one reading.


