**RESOLUTION NO. 2006 - 07**

**A RESOLUTION TERMINATING A FIRE AND EMERGENCY MEDICAL SERVICES  
TAX LEVY, DISPENSING WITH THE SECOND AND THIRD READINGS, AND  
DECLARING AN EMERGENCY**

**WHEREAS**, the Village of Newtown currently is collecting a tax levy outside the ten mill limitation in the amount of 3.5 mills for fire and emergency medical services pursuant to O.R.C. 5705.19(I); and

**WHEREAS**, in 2007, it will no longer be necessary to collect such levy as the Village is a member of the Little Miami Joint Fire District and such District will provide for its own funding beginning in 2007; and

**WHEREAS**, the Council of the Village of Newtown desires to terminate its levy for fire and emergency medical purposes for collections to be made after January 1, 2007;

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Newtown, State of Ohio:

**SECTION 1.** Effective for collections to be made on or after January 1, 2007, the 3.5 mill levy for fire and emergency medical services purposes being imposed by the Village of Newtown is hereby terminated and the County Auditor and County Treasurer are directed to discontinue collection of the levy after January 1, 2007.

**SECTION 2.** This resolution is passed pursuant to O.R.C. 5705.19(5).

**SECTION 3.** The Council of the Village of Newtown, by at least a three-fourths vote of all its members, dispenses with the requirement that this Resolution be read on three separate days and authorizes its passage upon the first reading.


**SECTION 4.** This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare, and safety of the Village of Newtown. The reason for the emergency is to timely notify the Hamilton County Auditor and Treasurer to stop collection of the levy in 2007.
